Requires an electronic tracking process be established for VBM application and ballots

Before voters can access the website to check on status of the application or ballot, the voter must provide:

- voter 's name and registration address and the last four digits of the voter's social security number;
 and
- the voter 's driver license number or personal identification card number issued by the Department of Public Safety.

The tracking process will also require each carrier envelope be assigned a serially numbered and sequentially issued barcode or tracking number that is unique to each envelope and recorded.

Separate early voting rosters required:

- early voting clerk shall maintain separate rosters of persons who vote early by personal appearance and persons to whom an early voting ballot by mail is sent
- Information shall be posted on the website at designated times to include:
 - o persons who vote early in person
 - o persons who vote early by mail

- Applications to file as a candidate to add "an indication of either not been finally convicted of a felony, or if convicted has been pardoned or otherwise released from the resulting disability
- Persons convicted of a felony must include proof of the pardon or release
- Providing false information on the form becomes a Class B misdemeanor
- Application must inform candidates of these provisions

SB 331 - Johnson [Signed by Gov] effective June 14, 2021

Clarifies who may serve as interpreters to voters at an in-person polling place.

- A voter may choose to bring their own interpreter.
- Interpreters appointed by election officers must be registered voters in the county or adjacent county, and take a prescribed oath.
- Meant to bring the law into compliance with a court ruling on the subject, which found that restricting interpreters to registered voters in the county was too restrictive
- If the voter also needs assistance translating the ballot, then the voter can receive assistance according to the "voter assistance" provisions under chapter 64, including the oath.

SB 598 - Kolkhorst [Signed by Gov]

Establishes for risk limiting audits of election results and calls for equipment to offer paper audit trail capability

- The risk-limiting audit (RLA) and the publication of audit results apply to an election that occurs after August 31, 2026, that contains a race or measure that is voted on statewide, and in which an auditable voting system is used.
- No later than 24 hours after all ballots are counted, the general custodian of election records, is to conduct a risk-limiting audit for a selected statewide race or measure.
 - SOS will adopt rules prescribing statistically accepted audit procedures necessary to select the precincts to be counted and the office or proposition to be counted.
 - SOS can appoint personnel to assist with the audit and poll watchers may be present.
- Calls for a five-county pilot program for the November 2022 election
 - SOS shall conduct a pilot program of the risk-limiting audit program beginning with the election taking place November 8, 2022 with at least five counties, one of which must be 500,000 or more in population
